



Free Whitening for Life Program

Free Professional Whitening for Life is a courtesy and privilege compliments of Rittenhouse Smiles. This program is extended to patients who prove themselves as individuals to take their oral hygiene and general dental health seriously. We believe it is extremely important maintain a healthy and beautiful smile. Consequently, we developed this program to reward patients who do so. Patients enrolled in this program will receive complimentary professional custom-made take home whitening trays and whitening gel for personal use.

This privilege, while free, does have some rules. Below is a brief description of these rules. Please read through them carefully and sign below, acknowledging that you understand how **Free Professional Whitening for Life** works.

Should any of the rules fail to me met, you will immediately be disqualified from the program and provided the opportunity to re-enroll for a \$30 activation fee.

Patient Activation Rules:

1. _____ (initial) Must be at least 18 years old or have parental consent
2. _____ (initial) Must complete initial hygiene cleaning, necessary x-rays, doctor's exam, and an additional hygiene appointment in six months
3. _____ (initial) Must comply with required dental care as stated by doctor
4. _____ (initial) Must make all schedule appointments. Cancellations must be made with a minimum of 48 hour notice and the appointment must be rescheduled within the next 2 weeks and must be completed
5. _____ (initial) Must not have any outstanding bills with Rittenhouse Smiles

Upon meeting these requirements, patients will receive complimentary upper and lower whitening trays along with professional whitening gel (1 syringe will be provided per year as recommended by the manufacturer).

Lifetime Maintenance Rules:

1. _____ (initial) Must maintain continued dental care as stated by the doctor and hygienist of Rittenhouse Smiles
2. _____ (initial) Must maintain continued hygiene care with Rittenhouse Smiles as specified by the doctor and hygienist (6 month cleaning appointments)
3. _____ (initial) Must comply with all Rittenhouse Smiles policies regarding payment and broken appointments
4. _____ (initial) Lost or destroyed applicator trays will be replaced at a cost to the patient. Applicator trays that no longer fit due to necessary dental work (crowns/bridges) will be replaced at no cost to the patient

Disclaimer: Any doctor or team member at Rittenhouse Smiles has the right to void this offer if deemed necessary based on patient health conditions, misuse, abuse or any other factor as determined by the Rittenhouse Smiles team member. A minimum gingival and tooth health status is required to receive professional whitening. Rittenhouse Smiles maintains the right to discontinue this program at any time for new and enrolled patients. *One syringe will be provided by year as recommended by the manufacturer.
